# About the course

#### Smart and Skilled Funding Availability in NSW

OCTEC Ltd can deliver this qualification through the Smart and Skilled Entitlement Full Qualification program for online delivery throughout NSW .Student's must meet Smart and Skilled eligibility requirements to enter this program.

#### **Delivery Mode**

This qualification program is delivered in an online training model. The program includes:

- Virtual training workshops (via Zoom)
- Homework / Self-Paced Structured Learning activities delivered through an online Learning Management System
- Compulsory work placement which will require to submit work based assessment tasks via the online system

#### **Duration and Amount of training (Student Commitment)**

This is a full-time study program that is completed over **26 weeks**, inclusive of **10-12 days** of work placement. Students considering this program should be able to commit up to 30 hours per week throughout the program. This course work will include:

- Virtual training workshops 2 days per week (6 hours per day)
- Up to 10 hours of Homework / Self-Paced Structured Learning activities each week
- 10-12 days of full-time work placement (students who are working part time in a retail environment *may* be eligible to complete this component in their workplace if their employer supports their study)

# Identification and documents for enrolment

When enrolling in this program, you will need to bring the following identification and documents with you:

- ✓ Unique Student Identifier (USI). If you do not have a USI, OCTEC will provide you with information on how to attain a USI
- ✓ Evidence of your citizenship, permanent residence status or refugee status. This may include <u>one</u> of the following:
  - ✓ Green Medicare Card
  - √ Passport or Birth Certificate
  - √Visa or residency documents
- ✓ Evidence of residency in NSW, This may include:
  - ✓ Drivers Licence or Proof of age card <u>OR</u>
  - ✓ Utilities bill
- ✓ Centrelink Concession Card or other proof of concession (if you are applying for concession fees)

# **Concession Eligibility**

Concession fees are discounted fees for disadvantaged students. For example a student who receives a specified Commonwealth benefit or allowance is eligible for a concession fee for this qualification.

# **Exemption Eligibility**

# Students who qualify for a fee exemption are:

- ✓ Aboriginal and Torres Strait Islander people
- ✓ People with a disability (who meet the exemption criteria)
- ✓ Dependent child, spouse or partner of a recipient of the Disability Support Pension
- ✓ Recipients of fee-free scholarships (refer to information booklet for more information)
